Incite® ST Soybean is a liquid bio-stimulant for seed treatment that supports enhanced plant growth by solubilizing soil nutrients, rendering them more accessible to plants, stimulating increased root development, and improving plant growth. Incite® ST Soybean is not a plant food product.

DIRECTIONS FOR USE

Use before the expiration date. Once opened, use the entire contents of the container within 24 hours. **When utilizing commercial seed treatment equipment**, refer to the calibration information of the equipment being used to achieve the desired application rate. Place the entire contents of the Incite® ST Soybean bladder in a treating tank dedicated to the use of inoculant products. Ensure thorough coverage of the seed with the product. Apply Incite® ST Soybean with other liquid inoculants, or otherwise apply the liquid inoculant products first and then apply Incite® ST Soybean as a second liquid coating to the seed. Incite® ST Soybean must be applied separately from the application of other seed treatment products in a wet or dry sequential method. Using a separate dispensing mechanism from other treatments being applied, apply Incite® ST Soybean at the endpoint after the last liquid product has been treated and before the polishing drum. Protect treated seeds from direct sunlight. Incite® ST Soybean may be applied in combination with other compatible seed treatment products. APPLICATION RATES

Crops	Recommended application rate
Soybean	Apply at a rate of 2 fl. oz/100 lbs of seed.

STORAGE AND DISPOSAL
