Induct® Peanut is a naturally occurring, non-pathogenic Rhizobium bacterium. It is a symbiotic nitrogen-fixing bacterium, to be applied as a seed treatment, prior to planting Peanuts or in-furrow when planting. Induct® Peanut is not a plant food product.

DIRECTIONS FOR USE

- Use before expiration date.
- Shake Induct® Peanut container well before use to ensure a uniform suspension. Settling of bacteria is normal during storage.
- Induct® Peanut can be used with either Bio-Shield® XT which is a bacterial extender at specified label rates.
- Once opened, use the entire contents of the container within 24 hours.
- Induct® Peanut may be applied in combination with other seed treatment products. For allowable time on seed prior to planting refer to www.mbfi.bio

Application Rate: 1.0 fl oz of Induct® Peanut inoculant per 1,000 feet of row.
