### 3. Composition / Information on Ingredients

**Product description:** 2 x 10<sup>9</sup> spores of *Trichoderma asperellum* per gram of product.  
Spores formulated in a polymer, talc carrier.

**Dangerous ingredients:** None.

### 4. First Aid Measures

**Inhalation:** Move victim to fresh air. If breathing is irregular or stopped, administer artificial respiration. Call a physician or poison control center immediately. Call a poison control center or doctor for treatment advice.

#### Methods for containment:

Avoid creating dust. Do not dry sweep dust. Wet dust with water before sweeping or use a vacuum to collect dust. Sweep up and shovel into suitable containers for disposal.

#### Advice on safe handling:

#### Storage conditions:

Keep the container tightly closed in a dry and well-ventilated place. Keep out of the reach of children. Keep away from food, drink, and animal feed. Keep in properly labeled containers. Keep cool between 40-80°F (4-27°C). Protect from sunlight.

Do not reuse the container.

Broad-spectrum fungicides and strong oxidizing agents.

Puncture the triple rinsed container and dispose of via an approved collector or recycler. Do not bury, burn, or donate the container to any other parties that may use it as a container for food or beverages.
