GENERAL INFORMATION

Priority DS Corn is a dry seed treatment bio-stimulant and seed flow aid that supports enhanced plant growth by solubilizing soil nutrients rendering them more accessible to plants, stimulating increased root development and improving plant growth. Priority DS Corn is not a plant food product.

DIRECTIONS FOR USE

Use before the expiration date. One measuring scoop, included, holds approximately 0.8 oz Priority DS Corn and treats approximately 80,000 seeds or 50 lbs of seed. Once opened, use the entire contents of the container within 24 hours. **When utilizing commercial seed treatment** equipment, refer to the calibration information of the equipment being used to achieve the desired application rate. Priority DS Corn must be applied separately from the application of other seed treatment products in a wet or dry sequential method. Using a separate dispensing mechanism from other treatments being applied, apply Priority DS Corn at the endpoint after the last liquid product has been treated and before the polishing drum. **For planter box treatment**, apply Priority DS Corn directly to the seed in the planter hopper, and ensure sufficient product is added to the seed according to the below dosage rates. Mix the treatment a few times with a paddle to ensure thorough coverage of the seed. Protect treated seed from direct sunlight. Priority DS Corn may be applied in combination with other seed treatment products. Contact an MBFi representative for the latest compatibility chart and recommendations on the use of these compatible product combinations.

APPLICATION RATES

Crop	Recommended application rate
Corn	Apply at a rate of 1.6 oz/100 lbs of seed (0.8 oz/80,000 seed).

STORAGE AND DISPOSAL

This product must be stored between 40 and 80°F (4 and 27°C). Failure to do so will cause irreversible damage and render the product unfit for use. Keep containers sealed when not in use. Store in the original container only. Do not reuse empty containers. Rinse the container thoroughly prior to disposal. Dispose of rinsate and container in accordance with local, state, and federal regulations. Keep out of direct sunlight. Components lose sterility after opening.
