Turbo-Seed® is a nutritional supplement that aids seedling emergence and vigor and additionally aids seed flow in the planter. Turbo-Seed® is to be applied as a seed treatment prior to planting, in planter hoppers.

# DIRECTIONS FOR USE

Use before the expiration date. One measuring scoop, included, holds approximately 2 oz Turbo-Seed®. When utilizing commercial seed treatment equipment, refer to the calibration information of the equipment being used to achieve the desired application rate. Using a separate dispensing mechanism from other treatments being applied, apply Turbo-Seed® at the endpoint after the last liquid product has been treated and before the polishing drum. For planter box treatment, apply Turbo-Seed® directly to seed in the planter hopper and add sufficient product to the seed according to the below dosage rates. Mix the treatment a few times with a paddle to ensure thorough coverage of the seed. Protect treated seed from direct sunlight. Turbo-Seed® may be applied in combination with other seed treatment products. Pea and Pulses	Apply at the rate of 4 oz/100 lbs of seed.	
Peanut	Apply at the rate of 4 oz/100 lbs of seed.	
Potato	Apply at the rate of 4-8 oz/100 lbs of seed.	
Sugar beet	Apply at the rate of 4-8 oz/100 lbs of seed.	
Sunflower	Apply at the rate of 4 oz/100 lbs of seed.	
Sorghum	Apply at the rate of 4-10 oz/100 lbs of seed.
