GENERAL INFORMATION

Twister® is a highly effective surfactant designed for use with insecticides, miticides, fungicides, herbicides, plant growth regulators, defoliants and nutrients. Twister® is designed for superior spreading, penetration and uniform distribution. The combination of oil and polymers in Twister® enhances the physical and chemical properties of the spray solution and assists in overcoming water repellency of the leaf surface. Twister® may be used with most pesticides, plant growth regulators, defoliants and fertilizer products.

DIRECTIONS FOR USE

Prior to use, read all the directions on this label and on the labels of the other manufacturers' products being used with Twister*. Test for compatibility prior to mixing and application with other chemicals. Always test new tank mix combinations before widespread use. Contact an MBFi representative for the latest compatibility chart and recommendations on the use of these compatible product combinations.

To ensure thorough mixing, it is suggested that you recirculate mini tanks and bulk tanks or shake containers before using them. Pre-rinse all tanks, spray lines or containers thoroughly before adding Twister® as it contains surfactants. Twister® should not be added to tanks, spray lines, or containers that may contain additional surfactant adjuvants. Coatings on the inner tank and spray lines, from previous chemicals sprayed, may be dissolved by Twister®, thereby releasing it into the mix about to be sprayed. If in doubt, add 10 ounces of Twister® to 20 gallons of water, circulate through the system for 20 minutes and spray to waste. Increasing tank mix compounds will increase precipitation and phytotoxicity risk. Extended high temperatures (>92°F) with some tank mixes may increase phytotoxicity risk and should be tested and observed before widespread use.

PRECAUTIONS

Do not apply to fruiting stages of pome fruit, cherries, table grapes or other sensitive or stressed crops without first consulting your MBFI LLC distributor or representative. Test for compatibility when combining in-tank mixes with EC products, copper and/or chlorpyrifos on sensitive crops. Twister* reduces dew formation for up to 7 days and therefore may increase the risk of frost damage in frost-prone areas.

MIXING

Fill the tank halfway with water. Add the required amount of other tank mix products while agitating. Add the remainder of the water. Add the recommended amount of Twister® last and continue agitation until completion of spraying. For best results, use within 24 hours of mixing. Antifoam and buffering agents may be used, if required.
