GENERAL INFORMATION

N-Zyme Plus is a liquid fertilizer for seed treatment, in-furrow, soil and foliar application, supplying cobalt, molybdenum and sulfur to the plant. N-Zyme Plus should preferably be applied in the early morning or late afternoon. The rate of application is dependent on the soil fertility and reaction required. The lower rates should be used for maintenance while the higher rates will correct nutritional deficiencies.

DIRECTIONS FOR USE

Shake the product thoroughly and dilute it in sufficient water to ensure adequate, even coverage without producing runoff. Agitate the spray mixture during application. Use only as indicated on this label. Clean applicator and mixing containers thoroughly after use and dispose of wash water where it will not contaminate crops, grazing, rivers, dams and boreholes.

GENERAL APPLICATION GUIDE

Seed Treatment	Apply at a rate of 1-4 fl. oz to 100 lbs seed using conventional seed treatment machines, rotating drums or other mixers. Ensure uniform coverage of the seed.
In-furrow Applications	Apply at a rate of 1.5-5.5 fl. oz/acre at the time of planting. Apply in-furrow or banded 2x2 alongside the furrow.
Soil Applications	Apply at a rate of 1.5-5.5 fl. oz/acre via fertigation methods (drench, drip and micro-irrigation).
Foliar Spray	Apply at a rate of 1.4-3.5 fl. oz/acre or 12.8-19.2 fl. oz/100 gal. The volume of water to be used will depend on the development stage and the weather conditions at the time of the application.

CROPS

Field crops: Alfalfa, barley, bean crops, canola, clover, corn, cotton, cowpea, flax, forage grasses, lentils, peanut, potato, rape (canola), rice, snap bean, sorghum, soybean, sugar beet, sugarcane, sunflower, oat, tobacco, wheat or other cereal grain.

Vegetable crops: Artichoke, asparagus, broccoli, cauliflower, cabbage, and other cruciferous vegetables, cucumber, kale, leaf lettuce, head lettuce, radicchio, and other leafy vegetables; melon, pumpkin, squash, and other cucurbits; onion, garlic, and other bulb vegetables; tomato, pepper, eggplant and other fruiting vegetables; strawberry, carrot, sweet potato, radish, beet and other root and tuber vegetables.

Fruit and nut crops: Apple, avocado, blueberry, and other bush berries; blackberry, raspberry, and other cane berries; sweet orange, lemon, mandarin, and other citrus; date palm, fig, grapes, hops, nectarines, oil palm, olive, persimmon, cherry, peach, plum, prune, apricot, and other stone fruit; almond, pecan, pistachio, walnut, and other tree nuts; pear, pomegranate, and subtropical fruit.
